# **FARMERS**

- 1. INTEREST ON FARM LOANS WILL BE REDUCED FOR LOANS UPTO RS. ONE LAKH.
- 2. FARM INSURANCE FOR ALL CROPS WILL BE GIVEN.
- 3. MNREGA AS WAGES FOR FARM LABOUR WILL BE REIMBURSED.
- 4. MSP FOR ALL CROPS WILL BE DECLARED AND IMPLEMENTED.
- 5. COLD STORAGES AND STORAGE GODOWNS WILL BE GIVEN PRIORITY BY THE STATE GOVERNMENT.
- 6. CO-OPERATIVE FARMING AND CO-OPERATIVE MARKETS WILL BE GIVEN FARM IMPLEMENTS TO HELP SMALL FARMERS TO GET AT A REASONABLE RATE FOR THEIR FARMING ACTIVITIES.
- 7. IMPORT OF ALL GRAINS WILL BE BANNED AND FARMERS OF THE STATE WILL BE ENCOURAGED TO GROW IN 3 YRS TIME.
- 8. PENSION WILL BE PROVIDED FOR SMALL AND MEDIUM FARMERS WHO REGISTER WITH THE STATE GOVERNMENT.
- 9. IRRIGATION PROJECTS WILL BE IMPLEMENTED TO BUILD CANALS IN ORDER TO INTERLINK WATER SOURCES AND BUILD CHECK DAMS TO SAVE WATER FROM BEING WASTED INTO THE SEA.
- 10. QUALITY SEEDS AND NATIVE SEEDS BANK WILL BE SET UP.
- 11. FARMERS WILL BE ALLOWED TO PRODUCE TODDY AND TODDY WILL BE DECLARED AS FOOD AND NOT AS ALCOHOL.
- 12. A COMMITTEE TO LOOK INTO THE PROBLEMS OF FARMERS WILL BE SET UP IN ONE DAY IF WE ARE ELECTED AND WITHIN 15 DAYS, A REPORT HAS TO BE BROUGHT OUT TO IMPLEMENT STRUCTURAL CHANGES IN THE FARMING SECTOR TO EASE FARMING ACTIVITIES
- 13. 2 ACRES OF LAND WILL BE LEASED OUT TO LANDLESS PEOPLE WHO WANT TO PURSUE FARMING.
- 14. NO AGRI LAND WILL BE ACQUIRED TO SET UP INDUSTRIES.
- 15. ALL PONDS, LAKES, AND CANALS TO BE DREDGED AND DEEPENED AND THESE PROJECTS WILL NOT BE TENDERED OUT, BUT CARRIED OUT BY THE GOVERNMENT ITSELF.
- 16. SOLAR POWER GENERATION WILL BE GIVEN A BOOST FOR FARMERS TO EARN MORE.
- 17. WILL STOP SUBSIDY ON ALL EDIBLE OIL IMPORTS AND WILL GIVE ALL-OUT SUPPORT FOR INDIGENOUSLY PRODUCED OILS SUCH AS COCONUT, PEANUTS, SESAME SEED OILS & OTHER OILS INDIGENOUSLY PRODUCED.
- 18. ORGANIC FARMING WILL BE GIVEN 100% SUPPORT WITH ECO-TOURISM.



19. ANIMAL HUSBANDRY – MOBILE DISPENSARIES WILL BE PROVIDED.

# WOMEN'S WELFARE

- 1. IF WE ARE VOTED TO POWER, WOMEN WORKERS WORKSPACE SAFETY COMMISSION WILL BE SET UP IMMEDIATELY, AND ALL OLD CASES OF COMPLAINTS BY WOMEN STAFF WILL BE TAKEN UP & DISPOSED WITHIN 2 WEEKS.
- 2. UNEDUCATED DESTITUTE WOMEN AND WIDOWS WILL BE PROVIDED WITH BASIC SKILL EDUCATION.
- 3. ALL CASES ON WOMEN SHOULD BE COMPLETED IN FAMILY COURTS WITHIN 90 DAYS.

# **EDUCATION**

- 1. ALL SCHOOLS IN THE STATE WILL HAVE THE SAME SYLLABUS, STANDARD AND QUALITY OF EDUCATION WILL BE IMPROVED IN ALL VILLAGE, GOVERNMENT & CORPORATION SCHOOLS.
- 2. FREE EDUCATION WILL BE PROVIDED FOR ALL ECONOMICALLY BACKWARD CHILDREN FROM PRE-KG TO UNDER GRADUATION.
- 3. IN ORDER TO JOIN MEDICAL STUDIES, IF CHILDREN HAVE TO TAKE NEET EXAM, THEN +2 EXAM WILL BE SCRAPPED, AS TOO MANY ENTRANCE TESTS ONLY LEAD TO STRESS IN CHILDREN AND PARENTS.
- 4. 10% OF THE MEDICAL SEATS WILL BE RESERVED FOR RURAL CHILDREN ON MERIT BASIS.
- 5. NO PRIVATE NEET COACHING CLASSES WILL BE ALLOWED AND GOVERNMENT HAS TO PROVIDE FREE COACHING FOR THE CHILDREN, FREE OF COST, FROM 8TH STD ITSELF.
- 6. CASTE, RELIGION COLUMNS, WILL BE SCRAPPED FROM SCHOOL, COLLEGE AND JOB APPLICATIONS.
- 7. AVAILABILITY OF EDUCATIONAL LOANS FOR STUDENTS WILL BE MADE EASY AND THE INTEREST RATES WILL BE SLASHED TO 6% .LOANS WILL BE RELEASED ON TIME
- 8. NO MORE SCHOLARSHIPS WILL BE GIVEN ON CASTE BASIS BUT ON ECONOMIC BASIS.
- 9. STUDENTS OF GOVERNMENT, VILLAGE, CORPORATION SCHOOLS WILL BE



GIVEN 50% IN GOVERNMENT JOBS ON MERIT.

- 10. PRIVATE INSTITUTIONS WHICH DEMAND DONATION / CAPITATION WILL BE SEVERLY PUNISHED.
- 11. ALL STUDENTS MUST BE COMPULSORILY INSURED BY THE INSTITUTIONS.
- 12. TRADITIONAL AND NATIVE GAMES AND ALL SPORTS WILL BE ENCOURAGED, SPORTS ACTIVITIES WILL BE GIVEN PRIORITY. ALL SPORTS PEOPLE, REPRESENTING THE STATE AND WILL BE GIVEN GOVERNMENT JOBS DEPENDING ON THEIR PERFORMANCE.
- 13. SPORTS CURRICULUM WILL BE INTRODUCED.
- 14. YOGA AND NCC WILL BE MADE COMPULSORY IN ALL SCHOOLS AND COLLEGES.
- 15. MEDICAL STUDENTS WILL HAVE TO WORK IN RURAL AREAS FOR A MINIMUM PERIOD OF 3 YRS.

#### **SENIOR CITIZENS**

- 1. ECONOMICALLY BACKWARD SENIOR CITIZENS (ABOVE 60 YRS OF AGE) SHALL BE ELIGIBLE FOR MEDICLAIM INSURANCE WITHIN THE BASIC LIMITS OF THE INCOME-TAX ACT.
- 2. SENIOR CITIZENS WILL BE GIVEN LIFE PROTECTION FROM ERRING FAMILY MEMBERS.

#### **FISHERMEN**

- 1. WE WILL PROVIDE COLD STORAGES IN ALL COASTAL FISHING VILLAGES.
- 2. ORGANIC AQUACULTURE WILL BE GIVEN A BOOST.
- 3. ALL FISHERMEN WILL HAVE TO BE COMPULSORILY INSURED.

# **GST/VAT**

1. REDUCTION OF VAT ON FUEL PRICES, WILL TRY TO BRING DOWN THE FUEL COST BY RS.20/-.



### **CORRUPTION**

- 1. ALL CORRUPTION CASES SHOULD BE TAKEN UP AND COMPLETED WITHIN 30 DAYS.
- 2. RTI WILL BE ENFORCED IN ALL DEPARTMENTS.

- 6 DIGITIZATION OF ALL LAND RECORDS AND ABOLITION OF BENAMI LAND HOLDING WILL BE TAKEN UP.
- 7 NO FREEBIES SUCH AS FANS, TV, ETC... WILL BE GIVEN.
- 8 IF ELECTED, ALL OUR MLA'S WILL FOREGO THEIR SALARIES & USE THAT FOR THEIR AREA DEVELOPMENT.

#### **INDUSTRY**

- 1. ALL MICRO, SMALL, MEDIUM, AND BIG INDUSTRIAL UNITS WILL BE CONSULTED TO KNOW THEIR PROBLEMS AND A COMMITTEE WILL BE SET UP TO SOLVE THEIR ISSUES.
- 2. EASE OF DOING BUSINESS, ALL CLEARANCES WILL BE GIVEN IN 48 HRS.
- **3.** ALL THE INDUSTRIAL ESTATES WILL BE SPRUCED UP, TO GIVE SUPPORT TO THE INVESTORS IN THE STATE.
- 4. MICRO, SMALL, AND MEDIUM INDUSTRIES WILL BE GIVEN ALL SUPPORT.

#### **SMALL TRADERS**

1. WILL BE INSURED AND GIVEN CREDIT FACILITY OF UPTO RS.5 LAKHS IN BANKS, IF THEY REGISTER WITH THE STATE GOVERNMENT

#### REAL ESTATE

- 1. LAND REGISTRATION TAX WILL BE REDUCED TO 2 % FROM 11% TO ENABLE EASIER LAND HOLDING BY ALL CITIZENS.
- 2. HOUSE FOR ALL HOMELESS CITIZENS WILL BE PROVIDED AS PER RULES.
- 3. THE FIRST DWELLING OF EVERY CITIZEN WILL BE GIVEN HOUSE TAX EXEMPTION.

#### **TRANSGENDERS**

#### POWER SECTOR

- 2. SOLAR POWER GENERATION WILL BE ENCOURAGED AND NEW RULES WILL BE INTRODUCED AS THE PRESENT GENERATION OFFER IS NOT LUCRATIVE TO THE INVESTOR.
- 3. STATE ELECTRICITY BOARD WILL BE TOTALLY REVAMPED.



# MEDICAL AND HEALTH SERVICES

- 1. HOSPITAL/MEDICAL HEALTH SERVICES WILL BE MADE FREE FOR ECONOMICALLY BACKWARD PEOPLE.
- 2. PRIVATE HOSPITALS SHOULD GIVE MINIMUM 10% OF THEIR BED CAPACITY FREE OF COST, EITHER FOR BED RATES OR SERVICE TO THE UNDERPRIVILEGED HONEST WORKER.
- 3.ALL ACCIDENT AND MEDICAL INSURANCE CALIMS SHOULD BE SETTLED IN 10 WORKING DAYS.
- 3. INDIAN MEDICINE LIKE SIDDHA, AYURVEDA AND UNANI WILL BE GIVEN EQUAL IMPORTANCE AS ALLOPATHY. RESEARCH IN THESE AREAS WILL BE ENCOURAGED.
- 4. MEDICAL TOURISM WILL BE GIVEN FULL SUPPORT.

#### **FOREST**

1.FOREST PROTECTION FORCE WILL BE SPRUCED UP.

#### POLICE FORCE

- 1. MODERNIZATION OF POLICE FORCES AND POLICE REFORMS.

- 3. WELFARE OF ALL SOLDIERS FAMILIES WILL BE REVIEWED.

# **TEMPLES**

- 1. HRCE DEPARTMENT, ENQUIRY INTO THEFT OF TEMPLE IDOLS AND TEMPLE LANDS WILL BE TAKEN AND THE GUILTY WILL BE PUNISHED SEVERELY.
